Stall holders and exhibitors Contract Rules

Participation Agreement

- 1. You will be allocated a space on the oval or in the hall where it will be your responsibility to set up your stall/display and to be ready for trade prior to the event opening at 11am. You can begin setting up at 8am.
- 2. Pack down and removal of all rubbish from your site will be the responsibility of the store holder. Pack up is at 4pm with vehicle access after 5.30pm if needed.
- 3. Because of the location, it is encouraged that where possible, store holders carry their belonging onto the site
- 4. Will you be needing vehicle access for set up and pack down YES / NO
- **5. Are you needing power** YES / NO

There will be a limited number of powered sites available

If approved a powered site, you must provide your own NEW 20m extension cord.

(No joints, No broken plugs)

- 6. Any antisocial behaviour or breach of agreement on the part of any participant at the festival will face immediate expulsion from the event, have their products removed from the site and may face criminal charges.
- 7. By signing this agreement, the stall holder indemnifies the event organisers against all claims arising from their participation in the event
